**TENDER FORM FOR THE SUPPLY OF FIRE FIGHTING MACHINERY/EQUIPMENTS
AND PERSONAL PROTECTIVE CLOTHING FOR THE YEAR 2014-15.**

The details of the items are shown in the schedule appended in the tender Form.

The Tenderers should abide by the following terms and conditions.

1. The participation in tender shall be through **e-Tendering mode** only.
2. The tender (Technical and Price Bid) will be accepted strictly upto 15:00 hours on 27/11/2014 as advertised in the Tender Notice. Tenders received after the due date and time will not be considered.
3. The Tender are invited in two - bid system i.e **Technical bid** and **Price bid** separately.
4. The Technical bid will be opened on 27/11/2014 at 16:00 hours as specified in the Tender notice.
5. Tenderer who qualifies in Technical bid as assessed by the Technical Committee, are only eligible for opening of Price bid. The date of opening of the Price bid will be communicated to the tenderer, five days in advance.
6. The bidder should be either a manufacturer of the Fire Fighting Garments and a proof of the same should be provided. If the bidder is not the manufacturer, Original Authority Letter from the manufacturer should be enclosed along with the Tender with the Tender Number and due date.
7. The bidding firm should either have a manufacturing facility or repair or workshop and should be confirmed and certified by the manufacturer in respect to the Fire Suit.
8. The bidder should also submit Test Reports / Certificates, alongwith the Tender No in original or Notaries by Public Notary for offered item as per the EN Standards mentioned in the specifications. The Test Report / Certificate should be issued from Govt / Govt approved Lab. Manufacturer shall provide all Test Certificate alongwith the Tender.
9. The Bidder should have not been blacklisted by any Government/Semi Government/PSUs. It is mandatory to submit Self declaration of the company in this regard.

10. Full quantity should be delivered in one lot.
11. The bidding Firm should be ISO Certified OR the Principals manufacturer supporting their distributor should be ISO certified. A Notaries Copy of the certificate to be enclosed alongwith the Tender.
12. An Earnest Money Deposit equivalent to 2.5% of the estimated cost of the tender is required to be sent along with the tender. The deposit should be in the form of Demand Draft drawn on State Bank of India or any other nationalized banks in favour of the Director of Fire & Emergency Services, Panaji valid for a minimum period of 180 days. The deposit sent earlier for other tenders will not be considered even if supplies are completed.
13. Earnest Money Deposit in the form of Cheques will not be accepted.
14. Tenders which are not submitted with the Earnest Money Deposit will not be considered unless accompanied by the necessary Earnest Money Deposit/ Exemption Certificates.
15. The tenderer shall submit detail technical brochure along with all the technical details of the equipment offered against the tender and original tender document duly signed and stamped.
16. The rates should be quoted 'free of charge destination Panaji - Goa' i.e. all the articles are to be delivered (door delivery) at the Directorate of Fire & Emergency Services, St. Inez, Panaji. No separate transportation/delivery charges will be paid for delivering the material at the place of destination. The VAT and other taxes/duties chargeable should clearly be mentioned separately, failing which no claim will be considered.
17. The rate should be quoted in Indian currency only and should remain valid for a period of six months from the date of submission of Tender.
18. The Tender "Technical Bid" should contain all requisite documents such as detail technical specifications, certificate of approval issued by recognized authority, testing reports, necessary drawings, brochure etc. for favourable consideration and technical evaluation of tender offer. Merely writing "as per requirement/specifications or complied" is not acceptable.
19. All the Machinery and Equipments should carry Guarantee/Warranty as per the norms of the Company/Manufacturer. Relevant Catalogue should accompany the Tender Form.
20. The items which are not as per specifications shall be rejected. Such rejected item should be collected within one week by the supplier at his own cost and this Directorate does not owe any responsibility to return the rejected material.

21. The rates of each item should be quoted independently.
22. Tenders not complete in all respects containing all above mentioned details will summarily be rejected.
23. The successful tenderers will have to deposit an amount equivalent to 5% of the total value of orders placed as Security Deposit in the form of Bank Guarantee/Demand Draft in favour of the Director, Fire and Emergency Services, St. Inez, Panaji - Goa, which shall be refunded only after effecting the supply in full/or after the completion of the Guarantee/Warranty period to the entire satisfaction of the Director, Fire & Emergency Services, and as per the terms and conditions of the Supply Order/Agreement and approved specifications.
24. The Earnest Money Deposit of the unsuccessful tenderers will be released after finalisation of the tender.
25. The successful tenderers will on receiving the supply order have to enter into an agreement within 15 days from the date of issue of order. The stamp duty payable in respect of such Agreement shall be as per the Law enforced in the State of Goa. Agreement without Security Deposit will be considered null and void. No correspondence will be entertained with the supplier in this regard and the supply order/ work order in such case will be cancelled and the E.M.D. will be forfeited.
26. No advance payment or negotiations of documents through the bank will be accepted. This being a Government Department, goods will not be insured, however, supplier may insure the goods at his own cost and risk.
27. The Department will not be responsible for damage of goods during transit.
28. The materials are liable for inspection conforming to specifications before acceptance.
29. The items adjudicated to the successful tenderer will have to be supplied within 60 days from the date of placing purchase order. No extension will be granted for reasons, which are not justifiable and acceptable to the Department.
30. If extension in delivery period is required then the party shall submit the request letter in writing stating the grounds on which extension is sought. In turn the Government (this Directorate) will grant extension in writing only if satisfied with reasons given in the request letter.
31. In case of failure on the part of the supplier to complete the delivery within the stipulated date indicated on the supply order/agreement or failure to replace/repair the rejected/damaged parts within the prescribed time period, a compensation at the rate of 1% per day on the value of the supply to a maximum of 10% of the Original Contract Price will be deducted from the payment due to the party or from the Security Deposit.

32. Director, Fire & Emergency Services at his discretion may reduce/waive the amount of compensation or cancel the order after forfeiting the Earnest Money Deposit and /or Security Deposit depending on the merit/genuineness of each case.
33. The supply should be strictly as per specifications and approved quality or else the same will be rejected.
34. The bidding firm shall take the individual measurement of each fire personnel for stitching of jacket and pant (two piece suit).
35. Reputed and experienced firms having infrastructure to provide after sales services with documentary evidence in execution of similar job should only apply for the tender.
36. The tenderer should furnish alongwith the tender a list of service provider in the State of Goa or nearby.
37. No conditional tenders from tenderers end will be accepted.
38. The nationality of the Tenderer should be indicated in the Tender.
39. Tender fee is not refundable and the Tender Form is not transferable.
40. The Director, Fire & Emergency Services, reserves the right to purchase the full quantity of articles required or part thereof and also to accept or reject any or all tenders without assigning any reasons.
41. The tender clauses are liable to alteration without notice and the decision of the Director, Fire & Emergency Services will be final.
42. Tenderers who do not agree to the above terms and conditions need not submit their Tenders.
43. Violation of any terms and conditions shall invoke forfeiture of the Earnest Money Deposit/Security Deposit.
44. All terms and conditions of this tender form shall form part of the Agreement and Purchase order.
